

RELEASE AND WAIVER

A COMPLETED AND SIGNED WAIVER AND RELEASE WITH ALL INFORMATION IS REQUIRED TO PRIOR TO CHILD/CHILDREN BEING ABLE TO PARTICIPATE IN ANY ACTIVITY AT KANGAROO JAKES

In consideration of being allowed to enter into the play area and/or to be able to participate in various activities at Kangaroo Jakes, the undersigned, on his or her own behalf and on behalf of any executors, heirs, successors and assigns, including the minors listed below hereby acknowledges and agrees as follows:

1. I understand that inflatables can be dangerous and hazardous and knowingly and fully assume all risks, known and unknown, associated with participation in activities at Kangaroo Jakes and waive any and all claims for damage to person or property arising from such participation. This release and waiver covers risks of death, serious injury and property loss whether arising from (a) negligence or carelessness on the part of the staff of Kangaroo Jakes, LLC or any other participant at Kangaroo Jakes, or (b) dangerous or defective equipment.
2. I understand that the activities at Kangaroo Jakes require strenuous exercise and various degrees of skill and coordination and certify that both the undersigned and the minors listed below are physically fit and able to participate in the activities available at Kangaroo Jakes and have not been advised otherwise by a qualified medical person;

In consideration of the admission of the child under my care, I, for myself and the participants named below, and our respective heirs, assigns, administrators, personal representatives, and next of kin, hereby release, waive and forever discharge and covenant not to sue Kangaroo Jakes, LLC and/or Armuchee Village, LLC and its owners, managers, agents, employees, officers, directors, trustees and all other persons and entities acting on its or their behalf, from any and all claims, actions, damages, liability, cost or expense including attorney fees which are related to or arise out of or are in any way connected to my child's participation in activities at Kangaroo Jakes or the use of the Kangaroo Jake facility.
4. I agree to comply with the rules and conditions of participation expressed or posted at Kangaroo Jakes. If the undersigned observes any significant hazard during their participation at Kangaroo Jakes, that I will promptly inform an employee of Kangaroo Jakes.
5. I acknowledge that my or my child's participation at Kangaroo Jake's is strictly voluntary. I certify that I am over 18 years of age; I have carefully read the above covenant not to sue and waiver of liability form and agree to all of the terms and conditions. Prior to signing this Release and Waiver, I have had the opportunity to ask any and all questions. I understand that by signing this waiver I am assuming all risks and am waiving and releasing substantial rights that I and/or my child have and possess and that Kangaroo Jakes will rely on this Release and Waiver.
